

‘TIL DEATH DOUGH US PART: VOODOO DOUGHNUT WEDDING GIVEAWAY

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. VOID OUTSIDE THE ELIGIBILITY AREA AND WHERE PROHIBITED.

Information on how to enter, the prize, and rules for redeeming the prize, form part of the terms and conditions of entry for the Sweepstakes. Participation in the Sweepstakes is deemed to be acceptance of these “Official Rules” (the “Official Rules”) and any other notices referenced herein.

ELIGIBILITY: The “‘Til Death Dough Us Part: Voodoo Doughnut Wedding Giveaway” (the “Sweepstakes”) is open only to legal residents of Arizona, California, Colorado, Florida, Illinois, Oregon, Texas, and Washington who are 18 years of age or older (or the age of majority in their jurisdiction of residence, whichever is older) as of the date of their entry. Participation constitutes an entrant’s full and unconditional agreement to these Official Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:00:00 PM Pacific Standard Time (“PST”) on January 27, 2026 and ends at 11:59:59 pm PST on February 14, 2026 (the “Sweepstakes Period”).

HOW TO ENTER: To enter, during the Sweepstakes Period, go to <https://lp.constantcontactpages.com/s1/D3HouNj/Wedding> and follow the instructions to enter, including by submitting all information required in the online entry form. Upon completion of these steps, you will automatically receive one entry into the Sweepstakes. All potential winners are subject to verification before any prize will be awarded. By entering the Sweepstakes, you consent to receive marketing emails from the Sponsor (you can revoke consent to receive marketing emails at any time by using the SafeUnsubscribe® link, found at the bottom of every marketing email). Proof of transmission is not proof of receipt. Sponsor’s computer is the official time-keeping device for the Sweepstakes and determines the order of receipt of entries. All decisions of the Sponsor are final and binding with respect to all matters related to the Sweepstakes.

LIMIT: Limit one entry per person during the Sweepstakes Period. Each entrant may enter their email address once during the sweepstakes period. Any attempts to obtain additional entries, including through multiple or duplicate accounts will result in disqualification. Entries become property of Sponsor and will not be returned. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “**authorized account holder**” is the natural person assigned

an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder. - a) One legal or non-legal wedding ceremony (ceremony is approximately 5 minutes in length) held at a participating Voodoo Doughnut retail location in Arizona, Colorado, Illinois, Oregon, Texas, or Washington for you, your partner, and up to twenty-four (24) guests. Sponsor will provide one officiant for the ceremony and the below other Prize Package elements. All other costs for the ceremony are the responsibility of winner. - c) One pair of 12" Newlywed Custom Doughnut Dolls (ARV: \$40);

- e) Magic Roast Brewed Coffee for twenty-four (24) people (ARV: \$60).

Approximate retail value of all prizes in Prize Package: \$350.

Winner must redeem prize (i.e., establish with Sponsor the date, location, and other details of the Voodoo Doughnut Wedding Ceremony Prize Package) between March 23, 2026 – December 11, 2026 or the prize is forfeited. Arrangement of specific Voodoo Doughnut Wedding Ceremony location and date to be arranged by Sponsor and Winner upon verification of eligibility and acceptance of prize.

Total prize value shall not exceed \$350. All costs, fees, and expenses associated with a prize or the acceptance and use of any element of a prize are the sole responsibility of the winner.

SWEEPSTAKES WINNER SELECTION: All eligible entries will be assigned a number and added to a pool of entries. The winner will be selected by a random number generator. On or about February 18, 2026, thirteen (13) winners will be randomly selected amongst all eligible entrants with a valid entry received during the Sweepstakes Period in a random prize drawing (each a "**Winner**"). **The potential winner(s) will be notified on or about February 20, 2026. WINNER MUST RESPOND TO WINNER NOTIFICATION MESSAGE WITHIN 7 DAYS OR THE PRIZE WILL BE FORFEITED.** Winners shall be contacted via the email used in their Sweepstakes entry. If a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only two alternate drawings will be held, after which the prize will not be awarded.

CONSEQUENTIAL DAMAGES, INCLUDING LOSS OF USE, LOSS OF PROFITS OR LOSS OF DATA, WHETHER IN AN ACTION IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, ARISING OUT OF OR IN ANY WAY CONNECTED TO YOUR PARTICIPATION IN THE SWEEPSTAKES OR USE OR INABILITY TO USE ANY EQUIPMENT PROVIDED FOR USE IN THE SWEEPSTAKES OR ANY PRIZE, EVEN IF A RELEASED PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
